

THE DISNEY IMAGINATION CAMPUS 50 TEACHERS CELEBRATION

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Disney Imagination Campus 50 Teachers Celebration ("Promotion") is sponsored by Disney Destinations, LLC ("Sponsor"), P.O. Box 10000, Lake Buena Vista, FL 32830 and is administered by Prize Logic, LLC, ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

- 1. PROMOTION PERIOD:** The Promotion consists of a contest ("Contest") and a sweepstakes ("Sweepstakes"). The Sweepstakes begins at 12:00 PM Eastern Time ("ET") on September 13, 2021 and ends at 11:59:59 PM ET on October 31, 2021 ("Sweepstakes Period"). The Contest consists of a submission period that begins at 12:00 PM ET on September 13, 2021 and ends at 11:59:59 PM ET on October 31, 2021 ("Submission Period") that is followed by a judging period that begins at 12:00 AM ET on November 1, 2021 and ends at 11:59:59 PM ET on January 7, 2022 ("Judging Period"). The Submission Period and the Judging Period are collectively the "Contest Period". The Sweepstakes Period and Contest Period are collectively the "Promotion Period". The Administrator's computer is the official clock of the Promotion.
- 2. ELIGIBILITY:** The Promotion is offered only to teachers, music directors, and administrators in education who are legal residents of the fifty (50) United States and the District of Columbia and at least twenty-one (21) years of age at the time of entry. Employees of Sponsor, Administrator, Sponsor's promotional partners, and any of their parent and affiliate companies and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings and children and their respective spouses, regardless of where they reside) and household members of each such employee, whether or not related, are not eligible. The Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Promotion.

- 3. HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, an eligible entrant must visit Disney50TeachersContest.com ("Website") and complete and submit the registration information including, but not limited to date of birth, a valid e-mail address, password (created by the entrant), their first and complete last name (no initials), phone number, street address (no P.O. Boxes will be allowed), city, state and Zip Code, school name where entrant works, school city, school state, school Zip Code, and grade level entrant teaches. Upon completing and submitting the registration information, entrant will receive one (1) entry into the Sweepstakes. **Limit:** Entrant will receive one (1) entry for registering during the Promotion Period.

- A. Opt-In To Marketing E-mails:** Upon registering for the Promotion, entrant may opt-in to receive marketing e-mails from Sponsor and may opt-in to receive

reminder e-mails about this Promotion. Entrant will receive one (1) entry for each opt-in for a total of two (2) additional entries into the Sweepstakes. Entrant may opt-out at any time. **Limit:** Entrant may receive two (2) total additional entries into the Sweepstakes during the Promotion Period.

B. Share with Friends: During the Sweepstakes Period, an entrant may obtain up to ten (10) additional entries by following the instructions on the Website and set forth below to share the Sweepstakes on Facebook and/or Twitter. HOW TO ENTER THE CONTEST: During the Submission Period, after registering or logging-in to the Website, an eligible entrant must then follow the on-screen prompts to submit an essay that describes an example where entrant encouraged their students to use their imaginations to creatively solve problems, including entrant's own creativity in presenting curriculum in a new and inspiring way ("Submission"). **All Submissions must comply with the restrictions outlined below.** Sharing or posting of the Submission on social media, including on Instagram, Facebook or Twitter, will not improve your chances of winning. **Entry Limit:** There is a limit of one Submission per person during the Submission Period. If more than one (1) entry is received from the same person, only the first Submission received may be considered valid.

Entry Requirements: All entries must comply with the following restrictions:

- Must be in English, except for commonly understood foreign words;
- Must comply with these Official Rules;
- Essay must not be longer than two thousand five hundred (2500) characters;
- Must not include any identifiable person(s) other than the entrant;
- Must not contain material that violates or infringes another's rights, including, but not limited to, privacy, publicity or intellectual property rights or that constitutes copyright infringement;
- Must be the original work of the entrant and must not contain images or artwork, music, quotes, parodies or other materials not created by entrant;

 - the taking up of arms against any person, government or entity or otherwise challenge or seek to overthrow any government;
- Must not contain any viruses, spyware, malware, or other malicious components that are designed to harm the functionality of a computer in any way;
- Must not contain, facilitate, reference, or use material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, gender, ethnicity, religion, nationality, disability, sexual orientation, political orientation, citizenship, ancestry, marital status, or age; and
- Must not contain material that is unlawful, in violation of or contrary to the laws or regulations in any jurisdiction where the Submission was created.

NOTE: If any Submission fails to comply with any of these Entry Requirements or any other provisions of these Official Rules, Sponsor and Administrator reserve the right to disqualify the entrant.

- 5. CONTEST JUDGING PERIOD:** During the Judging Period, the Submissions will be judged by a panel of qualified judges selected by the Sponsor ("Judges"). The Judges will score the entries according to the following weighted criteria: (i) Creativity: 40%; (ii) Originality: 30%; and (iii) Personality: 30% ("Judging Criteria"). The fifty (50) Submissions that receive the highest score will be declared the potential Contest prize winners. The Contest winners are potential winner pending verification of eligibility and compliance with the Official Rules. In the event of any ties, the entry with the highest score in criterion (iii) Personality will prevail. In the event there are still any ties, the tied Submissions will be judged again and the Submission with the highest overall score will prevail. If a potential winner is found to be ineligible or does not comply with these Official Rules, or otherwise does not accept their prize as awarded, he/she will be disqualified and the Submission with the next highest judges score will be named a potential winner. Administrator's, Judges', and Sponsor's decisions shall be final and binding in all matters pertaining to the judging and selection of the winners. Judging scores will not be revealed. Sponsor reserves the right to not award the Contest prize if, in its sole discretion, it does not receive a sufficient number of qualified Submissions.

Each Sweepstakes prize winner is deemed to be a potential winner pending verification of their eligibility and compliance with these Official Rules as determined by Sponsor, at Sponsor's sole discretion.
